- Cleaning of condensate drains
- Inspection of Freon levels
- Verify electrical parts meet factory specs
- Verify proper operation of emergency float switch
- Verify proper operation of cooling system (Spring)
- Verify proper operation of heating system (Fall)
- Recommend repairs as needed
